<b><u>Minor</u> REVISION comments</b>	<ol style="list-style-type: none"> <li>1) Abstract to be rewritten to cover the scope of work, methodology &amp; major findings in less or equal to 200 words or so.</li> <li>2) It would have been somewhat more practical to display Table(s) showing noise measurements in a typical mosque, church or an occasion for celebration/entertainment taken with respect to time, say in second. Thus provide a range of noise produced by noise equipment.</li> <li>3) We have evidence of sentence repetition, which is not allowed (see lines 160-162 versus 171-172; and lines 178-181 versus 182-184 or so.)</li> <li>4) There are cases of poor sentence constructions, see pages 139-142; 310-313, etc.</li> <li>5) Use of first person pronoun e.g. "I" or "my" is not allowed in technical writing, see pages 59, 151, etc. The entire manuscript should be edited.</li> <li>6) Text reference does not settle for surname and year of publication in over 50% of the references.</li> <li>7) All photographs/plates in the manuscript are not given figure numbers.</li> <li>8) On the climate change, as the author is not able to establish any link between noise and climate change or any relationship whatsoever. What is the justification, to include it in the title of the manuscript? See authors comment on lines 375-377.</li> </ol>
