The authors need to use same abbreviation of the Plants like MO, MI throughout the manuscript after first using the full form instead of using <i>Manifera indica</i> and <i>Moringa oleifera</i> or <i>M.indica</i> and <i>M.oleifera</i>.</p> <p>3 .In the title and in introduction part (line 23) the author mentions that Rats are used. While in the results section (tables) mice are mentioned instead of rats. The author(s) should clarify which animals are used in the abstract as well as introduction part.</p> <p>4. Tables 2 &3 need to be merged together and modified so that they are in a presentable way . Table 4 7 5 need to be clubbed together .The abbreviation used in tables need to be spelled out.</p> <p>The changes needed in the manuscript have been marked yellow along with the modification needed in the attached main manuscript file</p> <p>The manuscript needs modification in the following lines of the text Page 1: Lines : 8,9,10,13,15,16,17,18,19, 21,22,25,35,37,38,39. In the introduction part the text from line 43-47 need to be deleted or reduced.</p> <p>Page 2: Lines :1,3,18,23,25,28,31-35, 40,42</p> <p>Page 3: Lines:6,10,16,17,20,22,24,25,27,28,30,31</p> <p>Page 5: Lines: 7,9,14,17,18</p> <p>Page 6: Lines:2,3, 6-7. Last para of page 6 needs to be written in a proper way taking care of grammatical mistakes.</p> <p>Page 7: Table to be merged with previous table</p>
