	Line 35 to read mothers, line 114 under ash and CHO ± 8.7x10 ⁻²⁹ and 2.7x10 ⁻¹⁶ should be written only to 2 significant figures which mean ± 0.00 respectively. If the means in the results were in triplicate as indicated then the means should have been separated to give significance difference or not. It was wrong to use great difference when you have not separated the means. Line 107 involving mineral analysis was not done and if done, there was no result for mineral analysis. Line 199 was cited as Adeniyi et al; (2013) but listed as Adeniyi, B only. Line 203 was cited as Ajewole et al., (1999) but listed as Ajewole, K only. Lines 209 and 213 were not cited at all, but were listed. Line 235 Check if it is Dhellot or Dhello; Line 251 what is the initial of Idris? Lines 260,261 and 262 should be deleted as the Author was not cited but listed. Line 267, check the spelling of Kwennin or Kevenin et al., 2011. Line 276 was cited as Martin et al., 1998 and not Martin and Farrell (1998) Check which is correct. Line 282 Mc Clement instead please. Line 284 should have been cited as Mepba et al., 2007 and not Mepba and Eboh (2007). Line 297 Check if it is Onwardi or Onwordi, Line 301 was not cited but listed. Line 320,321 to be aligned properly. Line 325 to be FAO and WHO (2004). Line 329 was not cited but listed and should be deleted. The following references cited were not listed: Martin and Meitner, 1998, FAO, 2003, Tamengnon et al., 2012.
