<b>Minor</b> REVISION comments	<p>-Many times, author is using many abbreviations in the text without first giving their definition.</p> <p>-Author can also better the design and organisation of his manuscript.</p> <p>-Author has to make a conclusion of his job</p>

But it was sorry to find that the text didn't fit with the topic.
