Add the corresponding UCC reference values to Table 1. Mention the exact economic activities carried out within your study area. (There is no evidence that there are copper wire and steel manufacturing industries within and around your study location as contained in lines 148 and 149.) Expunge combustion of fossil fuels in line 148 because copper is not a primary pollutant from combustion and your study location has comparatively low fossil fuel combustion given that it is in a remote area. Reflect the findings of this study on other metals (Fe, Co, Ni, Cr, Zn and Pb) in the conclusion. 	
Minor REVISION comments	 Specify which elements are enriched either by natural or anthropogenic means and reflect same in your abstract. Revise the sentence in lines 11 and 12 "The results showed that all the swamp is slowly polluted". Standard Quality Guidelines in line 43 should be corrected to "Sediment Quality Guidelines". The arrow showing the enlarged map of Cameroon should be further stretched from Nigeria into Cameroon while the arrow showing the north point should also be drawn beside the enlarged Cameroon map. Give specific examples of what you referred to as natural processes in line141. Revise your grammar.
