<b>Compulsory</b> REVISION comments	<ul style="list-style-type: none"> <li>* I suggest the topic should read: A study on the awareness of climate variability and effects on water resources among farm women in Punjab.</li> <li>* Please rewrite the abstract in this order: Aim, research design, sampling methods, and method of data analysis, major findings and recommendation. In the findings, specific figures should be mentioned instead of the general words such as, most of, majority of etc.</li> <li>* There are several cases of grammatical errors, where singular and plurals are mixed up. Proper editing is needed.</li> <li>* In line 23, state the name of the country.</li> <li>* Line 25 is confusing. How can paddy occupies 28.51 lakh hectares (81.71%) out of which 29.82 lakh hectares (72.5%) is irrigated?</li> <li>* In line 28 remove full stop after 2014-15 and take to after the parenthesis.</li> <li>* In line 44, change "too" to "also". How does household use of water contribute to climate change?</li> <li>* In line 46, change "for" to "of".</li> <li>* The methodology needs better presentation. Study population was not stated and methods of sampling were vaguely presented. How the respondents were selected was also not clearly stated.</li> <li>* The study area map was poorly presented. NO scale, legend, latitudes and longitudes, the districts where the selected villages are located were not mapped and map not placed in a frame.</li> </ul>

Please represent more clearly.</li> </ul>	
<p><b>Optional/General</b> comments</p>	<ul style="list-style-type: none"> <li>* The paper should be well edited for structural and grammatical errors.</li> <li>* Discussion of results should be improved upon.</li> </ul>
