# The Effects of HAART on the Renal Functions of HIV Positive Patients in Nsukka, South East Nigeria

# 6 ABSTRACT

Some biochemical changes are observed during human immuno deficiency virus (HIV) infection. Highly active antiretroviral therapy (HAART) is usually initiated when CD4<sup>+</sup> count depreciates to 500 cells / mm<sup>3</sup>. This work, seeks to elucidate the effect of HAART on some of the biochemical changes caused by HIV infection. 63 subjects comprising, 20 apparently healthy control subjects and 43 HIV positive subjects ready to be placed on HAART (these subjects attended HIV clinic in Bishop Shanahan Hospital Nsukka) were recruited for the study. A known volume of blood, 10ml was collected from each subject through venepuncture prior to the initiation of HAART (basal sample) then 4 and 8 months into the administration of HAART. The levels of creatinine and urea, were determined, CD4<sup>+</sup> count was also determined at each presentation. The results showed that CD4<sup>+</sup> count increased significantly from baseline to 8 months into treatment (P = .05). Urea increased from baseline to 4 months into treatment (P = .05), but decreased to baseline levels by the 8 month (P = .05). There was no appreciable change in the creatinine level over the period of treatment (P = .05).

Even though the studied parameters improved because of treatment they were still significantly different from the observations made for the healthy control subjects (P = .05). There were significant negative correlations observed between CD4<sup>+</sup> count and urea on one hand and CD4<sup>+</sup> count and creatinine on another hand for the healthy subjects. On the other hand the correlations observed for HIV positive patients were not significant (P = .05).

#### 10 1. INTRODUCTION

The HIV/AIDS (human immunodeficiency virus/ acquired immunodeficiency syndrome) pandemic has 11 12 undermined the health of so many people, consequently affecting adversely, the work force and the economic stability of so many countries all over the world. World Health Organization (WHO) and United 13 14 Nations Programme on AIDS (UNAIDS) (2009), estimated that about 33.4 million people worldwide were 15 living with AIDS, with 2.7 million new infections per year. Some biochemical anormalies accompany 16 infection with human immunodeficiency virus as a result of the complications of the disease itself, for 17 example the body's normal response to infection depletes nutritional stores. Studies have shown that the antioxidant system of the body is adversely affected in HIV infection, and changes in the activities of its 18 19 components have been documented by several workers (Pasupathi et al., 2009). Other studies have also 20 stated that alanine transaminase (ALT) and aspartate transaminase (AST) activities usually increase in asymptomatic HIV sero-positive patients, signaling liver involvement in HIV infection. Patients especially 21 22 at the final stage of AIDS may develop, HIV associated nephrophathy (HIVAN) which leads to an increase in their serum creatinine levels (Rudolf and Rodriguez, 2003). The current treatment for HIV infection 23 consists of highly active anti retroviral therapy. These drugs which are classified into, Nucleoside Reverse 24 25 Transcriptase Inhibitors (NRTI), Non nucleoside reverse transcriptase inhibitors (NNRTI), Protease 26 inhibitors (PT), and Fusion inhibitors (FI) were introduced in 1996 to improve the patients' quality of life, 27 reduce HIV viraemia, and possibly prolong the life of the patient. They do not cure the patient of HIV or 28 prevent the return once treatment is stopped (Drain et al., 2007).

Since infection with HIV compromised the general well being of its patients, giving rise to many adverse biochemical changes, it became necessary that researchers direct their effort towards examining the biochemical effects of HAART (Highly active antiretroviral therapy) with a view to determining their exact effects on the parameters or systems under study, with respect to the population under consideration. A closer look at the, renal functions of these patients following treatment needed to be taken in order to appreciate the effects of these drugs as these have been observed to be severely affected by the infection. Hence the aim of the study is to examine the changes in the renal function markers (urea and
 creatinine) of HIV positive patients on HAART in Nsukka locality.

## 37 2. MATERIAL AND METHODS

## 38 2.1 Subjects

Forty three (43) HIV/AIDS subjects, attending the AIDS clinic of Bishop Shanahan Hospital, Nsukka south east Nigeria and twenty (20) apparently healthy subjects who served as controls were recruited for the

- 41 study. Informed consent was obtained from the participants and ethical clearance was sought for and
  - 42 obtained from Annunciation Hospital ethical clearance committee, Emene Enugu Nigeria. Venous blood,
  - five mililitre (5 ml), was aseptically collected from each subject, three mililitre (3 ml) aliquot was allowed to clot and centrifuged at 3000 rpm for 5 minutes, to separate serum from erythrocytes. The serum was
- 45 pipetted into a clean serum bottle and either analyzed immediately or stored at -4 ℃ for a maximum of 48
- 46 hours. A two milliliters (2 ml) amount of the sample was emptied into a sodium EDTA container for CD4+
- 47 count. Retroviral screening was done using the requisite methods. CD4<sup>+</sup> enumeration was done by the
  48 principle of flow cytometry using partec cyflow machine.
- 49 The results were presented as mean ± standard error of mean. Differences between the results of the
- 50 control subjects, and those of HIV positive subjects, before the commencement of HAART, 4 Months and
- 51 8 months into treatment, were analyzed using Student's t test. Effects of HAART on the biochemical
- 52 parameters of HIV positive patients' were analyzed using ANOVA. Pearson correlation was employed in
- analyzing the relationship between CD4<sup>+</sup> count and the biochemical parameters.

#### 54 2.1.1 Inclusion Criteria

HIV positive patients not yet on antiretroviral therapy but are due to be placed on it by virtue of their CD4<sup>+</sup> counts (patients with CD4<sup>+</sup> count 500/mm<sup>3</sup> of blood and below were placed on HAART).

#### 57 2.1.1.1 Design of the Experiment

- All subjects were tested at presentation (after being confirmed positive), 4 months after the initiation of the antiretroviral therapy (Combivir N is the HAART in use in Bishop Shanahan Hospital, it contains zidovudine, lamivudine and nevirapine) and 8 months after. Their CD4<sup>+</sup> counts were also estimated, at all
- 61 the presentations. The subjects were divided into 4 groups as follows:
- 62 Group 1 (G1): HAART naïve subjects (forty three HIV positive individuals ripe for HAART initiation).
- 63 Group 2 (G2): The same HIV positive subjects four months into treatment with HAART.
- Group 3 (G3): The same HIV positive subjects eight months into treatment
- 65 Group 4 (G4): Control (twenty apparently healthy individuals).

#### 66 3. RESULTS AND DISCUSSION

Table 1 shows that mean  $\pm$  SEM of urea and creatinine levels for the control subjects (group 4) 14.71mg/dl (SEM = 3.80) and 0.93mg/dl (SEM=0.12) were lower than those of groups 1,2 and 3 but while the differences were significant (*P* =.05) for urea, they were not significant (*P* = .05) for creatinine. The highest concentration of urea, was observed for (group 2) 35.5mg/dl (SEM=13.92). The difference between urea concentrations for group 2 and groups 1, 2 (27.14mg/dl (SEM= 11.O2)) and 3 (27.86mg/dl) (SEM = 8.72)) were significant (*P* = .05).

- However the differences between the groups for creatinine were not significant (P = .05). Group 1 showed the lowest CD4<sup>+</sup> count (247cells/mm<sup>3</sup>; SEM=71) (P = .05) while group 4 showed the highest CD4<sup>+</sup> count (1023 cell/mm<sup>3</sup>; SEM = 203) (P = .05). Separate comparisons revealed that the differences between the CD4<sup>+</sup> count of group 1 and groups 2 (310.0 cells/mm<sup>3</sup>; SEM= 106) and 3 (319.0 cells/mm3; SEM = 138) were significant (P = .05). However, the difference between the counts for groups 2 and 3 was not
- were significant (P = .05). However, the difference between the counts for groups 2 and 3 was not significant (P = .05).
- Significant negative correlation was observed between  $CD4^+$  count and urea level (r=0.41; P = .05) while
- the negative correlation that was observed between  $CD4^+$  count and creatinine, was not significant (r=0.14; *P* = .05).

The results of the work showed that the use of highly active antiretroviral therapy (HAART) led to a steady increase in  $CD_4^+$  count from the HAART naïve stage to eight months into treatment this agrees with the work of lbe *et al.*,(2013) which showed that the use of HAART reduces the replication of HIV, leading to the improvement of  $CD_4^+$  count and ultimately the general well being of patients. The level of the renal function marker, urea increased from the baseline (HAART naïve) stage, to the 4<sup>th</sup> month of treatment, but reduced by the 8<sup>th</sup> month to about the same level as the baseline value. On the other hand there was no appreciable change in the level of creatinine over the duration of the treatment.

The effect of HAART on the renal function markers of the subjects proved interesting, this is because after four months of initiation of HAART, urea increased showing a negative effect on renal function, but eight months into HAART, the urea level dropped back to almost baseline. This means that the kidneys may have experienced an initial negative effect in reaction to the initiation of the drug, but recovered after sometime. On the other hand creatinine levels did not display any significant change.

This brief period of renal function alteration, may be attributed to the side effect of the drugs. HAART can 99 100 cause renal injury through a variety of mechanisms: direct renal tabular toxicity (Fanconi-like syndrome 101 and distal tabular acidosis), obstruction (Crystal deposition in the kidney) and glomerular lesions 102 (Biagionisantos et al., 2010). The work of Rudolf and Rodriguez (2003) also suggested that changes in 103 renal function can also occur especially in severe HIV infection, involving HIV associated nephropathy. 104 The good thing is that there seemed to be a recovery phase showing that there can be a resultant 105 positive prognosis with the continued use of HAART as regards renal function. Typical examples are seen 106 for creatinine levels, which became almost the same for the healthy control group and the HIV positive 107 group, eight months into treatment.

108 Correlations between  $CD_{4+}$  count and urea and creatinine in both HAART naïve and HAART initiated HIV 109 positive patients, were not significant. On the other hand for the apparently healthy control subjects 110 parameters urea and creatinine, showed negative correlations (inverse relationship) with  $CD_{4+}$  count.

111 It is noteworthy that urea and creatinine, showed higher baseline levels and activities for HIV positive subject than was found in their apparently healthy counterparts. This can be attributed to the fact that the presence of the virus itself and its destructive activities can lead to damages in crucial organs like the kidneys and the liver leading to increases in the levels of the renal function markers, prior to the use of

HAART. This is in consonant with the work of Biagionisantos *et al.*, (2010) which claimed that in patients with AIDS, kidney function can be compromised, due primarily to the infection itself or secondarily to the

117 side effect of HAART.

# 118 **4. CONCLUSION**

The commencement of HAART for the study population led to an increase in their  $CD_{4+}$  count. The levels of the renal markers creatinine and urea, showed a picture of an initial derangement but an attempt towards recovery by the system. These effects are indicative of a positive prognosis with regard to HIV/AIDS infection which resulted from the initiation of HAART.
