In the organizational structure of the text, several times the author stopped putting space between the text and the first parentheses. On several occasions the author stopped putting space between the abbreviation of the name of the species and the name of the genus. In the discussion, he wrote only wrong: "... the presence noly in the blood of the experimented animals. It is proved that no influence of recombinant L.lactis..."

Multiple parts of text without space after end point. And in some cases missing the end point.

The words "identification" and "purifications" were wrote wrongs, the author wrote "identification" and "purifikation". *E.g.*: "...quick PCR purifikation Kit (QIAGEN Inc), and digested ..."

The author wrote in this phrase "...Microbial strains of recombinant Lactococcus lactis and normal NZ 9000 were obtained from the..." without put the scientific name in the correct form.

The word *In vitro* must be in italic form: "...in recombinant strains in vitro."

In table 1, please organise the first column, alignment it.

Pay attention the punctuation.
