

Line 17-18 and 238-239: Study is designed to find out cause of delayed presentation of breast cancer, not the predictors of breast cancer. Please correct taxt and tables accordingly and do not inter-mingle these two. Age at first pregnancy, Early menarche, late menopause etc. are mixed with low level of education, poverty etc. Aim of study must be clear, and so also Conclusion.
